FIRST AID

KEEP OUT REACH OF CHILDREN.

STORAGE

Keep in original container tightly closed in a safe place when not in use. Store in a cool and dry location away from oxidizing and reducing agents. Keep away from heat, sparks and sources of ignition. Keep away from food, drink and animal feedstuffs.

SPILL CLEANUP

Eliminate sources of ignition and ventilate area. Soak up spill with absorbent material (kitty litter, granular clay, earth) and collect into a waste container. Wash spill site with water after material pick-up and dispose with waste. See DISPOSAL statement below.

AGRAL 90 Non-Ionic Wetting & Spreading Agent mixes with all types of water. The rate of AGRAL 90 Non-Ionic Wetting & Spreading Agent is indicated for the control product spray mixtures or other uses listed below. Control product spray mixtures, their preparation and uses are to be derived from the individual labels for the control products.
