

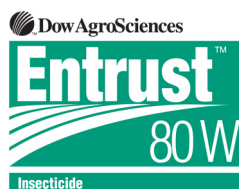

## Insect Control

### Entrust 80W in Organic Production

In the Spring 2012 edition of SpudSmart.com, an article titled "Equipping the Organic Toolbox" featured challenges and



methods growers use to successfully produce organic potatoes. Amongst the various crop husbandry and inputs is Entrust 80W. In the article, Isaiah Swidersky, a producer of organic red, blue and yellow certified potatoes in Alliston, Ontario, says he uses Entrust 80W for control of Colorado potato beetle (CPB). Although CPB isn't known in the Fraser Valley of BC, Entrust nevertheless is an effective control for many other insect pests, including lepidopterans such as diamondback moth and cabbage looper.

A Group 5 insecticide, Entrust 80W is a Naturalyte class chemical produced by Dow AgroSciences. It contains the active ingredient spinosad that is created through the fermentation of living organisms. Like its earlier cousin Success 480, Entrust 80W is environmentally safe and fits well into Integrated Pest Management programs (IPM). It is registered for use in pome & stone fruit, potatoes, turf and ornamentals, a wide range of vegetables, cranberries, caneberries, bushberries, low-growing berries (including strawberries), grapes and greenhouse vegetables.

Entrust 80W once again has an emergency use registration for control of Spotted Wing Drosophila (SWD) in grapes, strawberries, caneberries (including

raspberries), bushberries (including blueberries) and stone fruit in BC, Alberta, Ontario, Quebec, PEI and Nova Scotia. The emergency registration ends on November 30th, 2012.

Be very careful in its use, as Entrust 80W is toxic to bees, parasitoids, predatory mites, and aquatic invertebrates.
