# Give Your Transplants a Boost

Here is something to try to increase transplant survival and give them a fast, vigorous start:

- Two days before pulling the transplants, spray them in the seedbed with **Antistress Antitranspirant** at 3 L/200 L of water. This helps prevent them from drying out.
- Use the following mix as a starter solution or as a transplant dip: Terra Boost at 0.15 L with Terra Feed at 0.5 L in 100 L of water. This mix encourages quicker root development and less misses after transplanting.

# New Registrations in Vegetable Crops

#### Matador 120 EC

The people at Syngenta must be working hard. This is



the second advisor in a row in which new registrations have been announced for Matador 120 EC. This time, this synthetic pyrethroid insecticide has been fully registered for Western Bean Cutworm in sweet corn, and both Carrot Rust Fly and Carrot Weevil in carrots. In sweet corn a range of 34-75 mL/acre with a pre-harvest interval (PHI) of one day. For carrots, the rate is 34 mL/acre and the PHI is 14 days. The re-entry interval (REI) is 24 hours. No more than three applications per year are allowed.

#### Coragen

A Group 28 suspension formulation, Coragen insecticide became available in 2008. It now has a minor use registration in



sweet corn for control of Corn Earworm and European Corn Borer. It can be used at a rate of 100 to 150 mL/acre, but only up to an accumulated maximum of 450 mL per acre per season. Coragen can be used up to one day to harvest, and the REI is 12 hours.

### Ripcord 400 EC

Emergency use registrations are characterized by a limited time, after which the



registration expires. In the case of Ripcord 400 EC the registration dates are April 26 to October 31, 2010. The registration is for control of Cabbage Root Maggot flies in rutabagas and turnips.
